Below are the descriptions of the groups we are getting going and getting ready for launch.

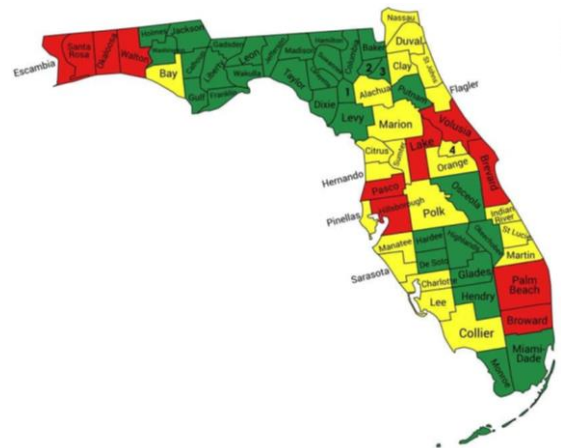
LET'S GET ORGANIZED!

To help us communicate and focus our efforts on getting a full forensic audit here in FL, work groups are being set up within the Chat. These groups will build the evidence needed to demand a full forensic audit.

To start, there will be 4 Groups (see below). More will be added as needed.

1. **FL FOIA Group** –

This group will execute requests for publicly available election information that isn't accessible online. (Note: The Action we recently took to request the election vendor contracts from the local election board is an example of the work this group will focus on.)



2. FL Documents Group -

This group brings together detail-oriented individuals, including paralegals and attorneys. We want these people to review and dissect the following:

- Any FOIA documents that we receive back and the legal terms
- Guidance to filing the FOIA and assuring that they are detailed enough to get what is needed,
- To provide guidance if our request is denied & must be escalated to the District Attorney or AG
- Any help drafting any documents that may be needed in the future
- Strategically plan how and when we request documents to prevent any officials from grouping us together

3. FL Research Group –

This group will be the data analytics team. They will research and connect dots about the data we collect to identify trends or patterns (e.g., was there a pattern to who received unsolicited mail-ballots). The group will need some professionals that can utilize excel spreadsheets, build data set, create presentations, etc., and be cyber-sleuths / techies. The work of this team will be used with elected officials, courts (if needed), etc.

4. FL Communications Group -

This group will oversee calling and emailing officials county by county. They are our front-line fighters. We choose a county a day and they hammer the phones and emails. Until the public request documentation is received, they will be calling counties to ask questions about election operations and laws. They will be requesting and audit of all counties and recording calls and emails they receive from officials.
